We have reserved a different week at the fairgrounds for next year, hoping to avoid graduation parties and annual campouts so that more of you have the opportunity to attend. As you will also see within this issue, we are in dire need of more volunteers for certain events. This organization cannot be run by just our board members. On a separate note, a heads up for our members that enjoy staying at Casey's Riverside RV Park in Westfir, Oregon. In case you are unaware, they have rules for RV's. Your rig cannot be any older than 2015, unless you send them photos of the exterior and they possibly make an exception for you. They denied one of our members from McKenzie River Drifters. Their chapter will no longer be going there because of it. Also, Bill and I had made prior reservations at Casey's last year when the Cedar Creek Fire broke out (Bill's brother and wife had made reservations also, so we had two sites). Westfir was in jeopardy of being evacuated, so the day before our reservation date, we all decided to cancel. We were afraid of driving the three hours it takes to get there and being turned away because of the impending fire. Andre, the owner, claimed that they've never been evacuated, so he refused to refund what we'd already paid for a three day stay (\$153 plus tax, per site!). As we feared, Westfir was evacuated the next day ... the day we were supposed to arrive ... but Andre again refused to refund us, nor would he offer another weekend's stay. We will never go there, now. What terrible customer service. Just be aware of these things if you decide to book a stay there.

These are extremely crucial positions to our organization and must be filled immediately. Please consider volunteering for a position that is vacant:

SECRETARY - Your role in board meetings include taking minutes at our monthly Zoom meetings and reading minutes of last meeting. Take minutes at any/all State Meetings and read minutes of last State Meeting. Take roll call of chapters at State Meetings. Keep and maintain the minutes of all meetings. Ensure that the records, policies, and procedures of the organization are appropriately maintained and made available to members. In conjunction with the Assistant Secretary, maintain all records of membership. Maintain ORCA's governing documents. Verify any vote counts at State Meetings. Occasional other secretarial duties when requested by the State Director. We need someone with communication skills, organizational skills, writing skills, and who is a team player.

CHAPLAIN - Your role is detached from any particular religious tradition. The role is largely a formal one, but not extensive nor with many defined tasks. Typically, the duties consist of providing a prayer or some form of invocation at rally opening ceremonies, meetings, shared meals and for closing ceremonies.

SOUND DIRECTOR – Your role is to coordinate equipment to achieve an efficient and quality sound system with recorded music for our memorial ceremonies or events as needed. Responsibilities include setting up and maintaining audio equipment, enhancing audio with appropriate sound effects and fixing sound-related issues.

We cannot run a smooth organization without the help of our volunteers and cannot continue without these positions being filled. This will be a minimum two-year commitment. Please contact Barb Taylor at 503-810-7585 to volunteer. Thank you!

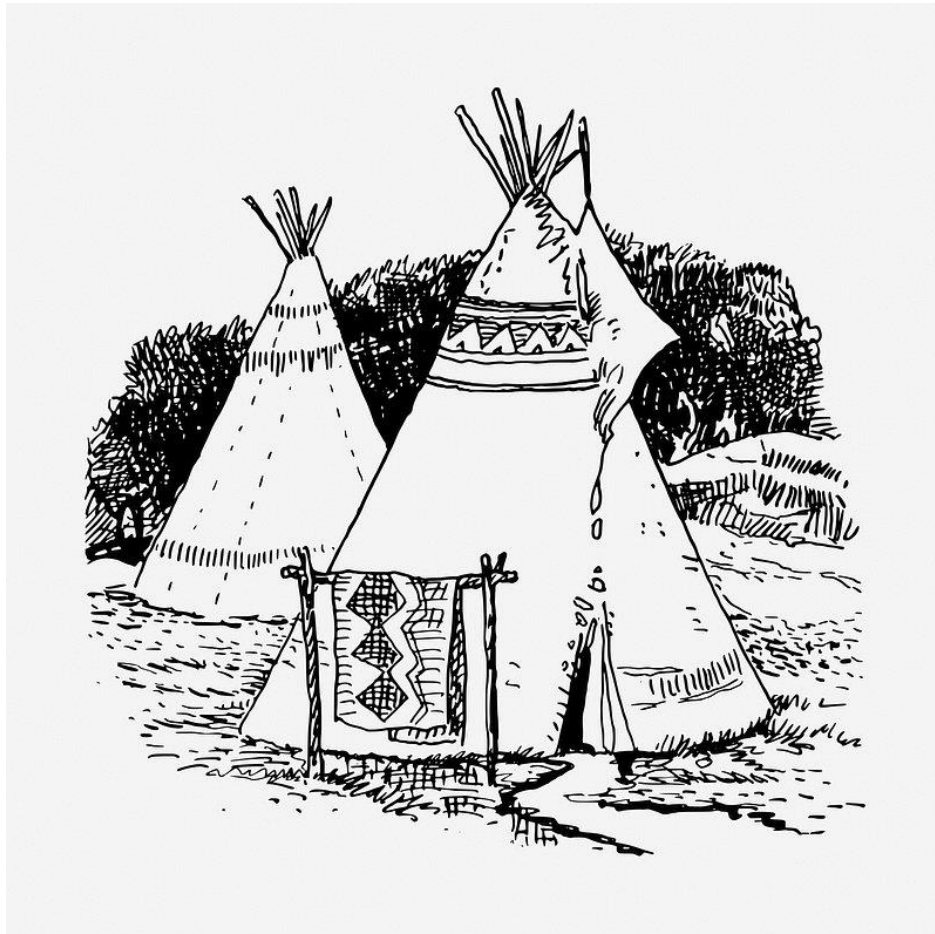

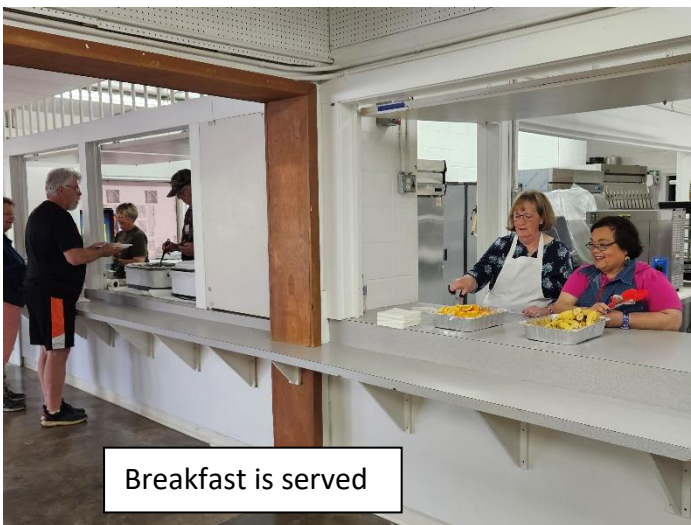

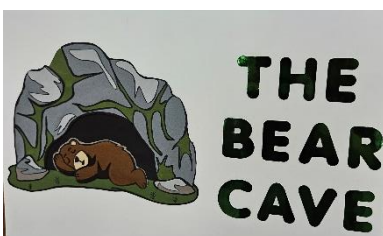

SHRIMP SPREAD

INGREDIENTS

- 1 envelope Knox unflavored gelatin
- 3 tablespoons water
- 1 can cream of mushroom soup
- 1 8-oz pkg cream cheese
- 1 cup mayonnaise
- 1 can broken shrimp (rinsed and drained) - (can substitute chopped fresh shrimp for canned)
- 1 bunch green onions (chopped)
- 1 cup chopped celery
- 1 box of Wheat Thin Crackers (other crackers can be used)



INSTRUCTIONS

1. Chop shrimp, green onions and celery. In medium saucepan, dissolve gelatin in water over low heat. Increase to medium-low and add mushroom soup and cream cheese. Stir occasionally (or more if necessary) until smooth. Remove from heat and add mayonnaise, green onions, celery and shrimp. Stir until well blended and pour into mold or bowl. Refrigerate for at least 8 hours or overnight before serving. Unmold or serve in bowl.
2. Serve cold with Wheat Thins or desired cracker.

RED, WHITE and BLUE TRIFLE

INGREDIENTS

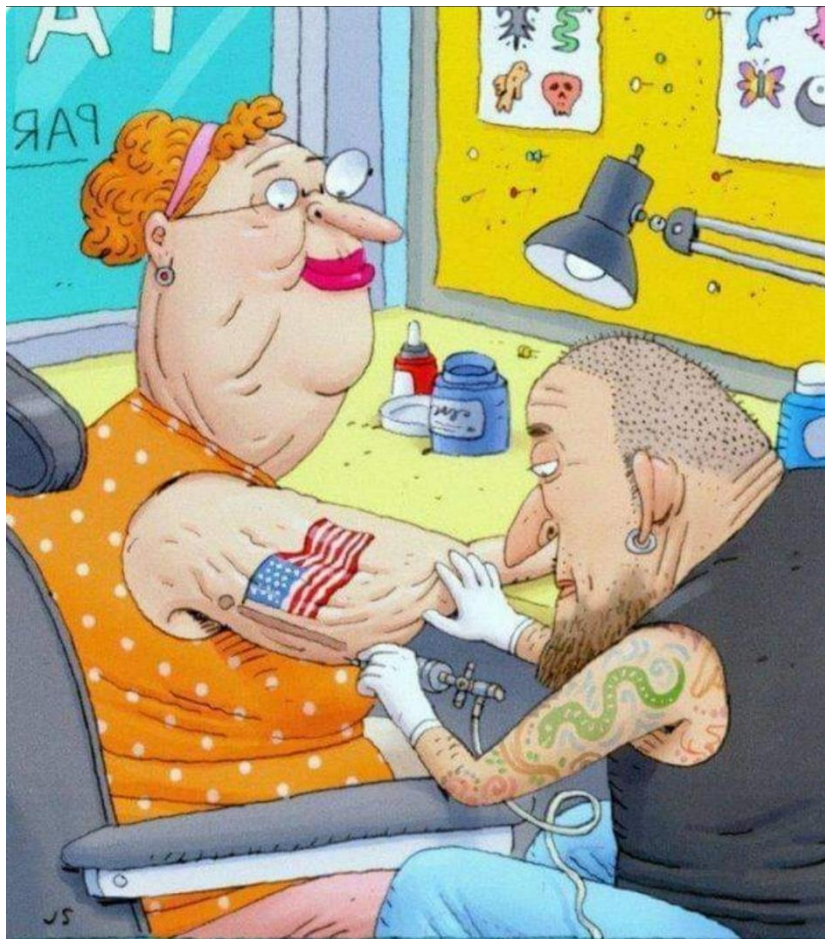
- 8 oz. cream cheese, at room temperature
- 1/2 c. granulated sugar
- 1 1/2 c. heavy cream
- 1 tsp. vanilla extract
- 1 lb. pound cake, cubed (store bought or homemade)
- 2 6-oz. containers blueberries (about 2 cups)
- 2 6-oz. containers blackberries (about 2 1/2 cups)
- 1 1/2 qt. strawberries, stems removed, sliced



INSTRUCTIONS

1. Combine the cream cheese and granulated sugar in the bowl of a stand mixer with a paddle attachment. Beat on medium-high speed for 1 to 2 minutes until smooth. Scrape the sides and bottom of the bowl. With the mixer on medium, slowly add the heavy cream and vanilla and mix until combined. Switch to the whisk attachment and whip at medium speed until soft peaks form and the mixture is easy to dollop.
2. Place a single layer of cake cubes in a large trifle dish (about 12 to 14 cups). Top with 2/3 of the blueberries and blackberries, then 1/2 of the whipped cream (about 2 cups), then 2/3 of the strawberries. Repeat the cake and cream layers once more, then decorate the top with the remaining berries. Serve immediately or make in advance and store for up to 24 hours in the refrigerator.

Help for Seniors. What is phishing?

Phishing (pronounced “fishing”) is a type of internet hoax in which scammers use email and other methods to steal personal information, such as financial details or account passwords. This approach earned its unusual name because it uses attractive “bait” to lure people to websites and solicit their data under false pretenses. Phishing is not the same as spam. While spam is just another term for junk mail and unwanted ads, phishing attacks are deliberate attempts to steal your information and use it in harmful ways.

How does phishing work?

There are three main components to a phishing scam:

1. The attack is conducted via electronic communications. Although email is common, phishing can also be carried out via text messages, social media accounts, voicemail, and even phone calls.
2. All forms of phishing aim to convince you that a fake communication is real and credible. The attacker claims to be an individual or organization that’s familiar and trustworthy to you.
3. The goal of a phishing attack is to obtain sensitive personal information, such as login credentials, bank details, or credit card numbers.

Some common phishing attack examples include:

- **A plea for help:** With a goal of tugging at your heartstrings, the attacker sends you an email pretending to be a good friend or relative (ie: your grandchild). They claim to be in financial dire straits and request your assistance immediately. How are cyber criminals able to impersonate people you know? With social media, scammers have access to more of our personal information than ever before. This allows them to make their messages highly targeted—and often very believable.
- **You’re the grand prize winner:** You receive a text message congratulating you on being the winner of a very big prize, whether it’s an irresistible travel package deal or free tickets to the event of the year. You’re asked to provide your personal details in order to claim your award, and many will require you to pay a designated amount to get your reward. “Pay” is a giant red flag.
- **Your bank account has been compromised:** You get an “urgent” notice that appears to be from your bank, alerting you of suspicious activity on your account. You’re then asked to click a link that takes you to a website, where you’ll be prompted to confirm your bank account information.
- **The government is after you:** Few things in life are as jarring as an authoritatively worded notice from the Internal Revenue Service (IRS). Scammers know this, which is why many phishing emails appear to be from the U.S. government. An email like this typically has a threatening tone and mentions big, scary penalties—unless you provide the payment or personal data they demand. The IRS will never contact you by email or by phone ... they use U.S. mail ONLY.

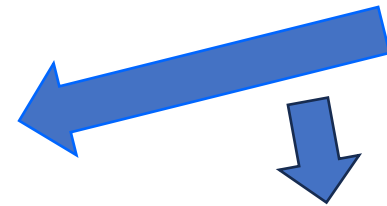

How do you avoid phishing scams?

Knowing how to identify phishing emails and texts means knowing what to look for. While scammers are always changing their approaches to evade detection, certain red flags can help tip you off to trouble. Some telltale signs of a phishing email or text message include:

- Offers that seem too good to be true
- High-pressure sales pitches that stress urgency
- Alerts that there's a problem with your account (ie: suspicious activity or outdated payment information)
- Shortened or misspelled links
- Emails that don't address you by name
- Messages with poor grammar and spelling
- Direct requests or demands for payment
- Requests to confirm personal information

This is a type of phishing email I receive constantly. Your first clue is to look at the email address of the sender. Does this address (see yellow highlight) look like a legitimate email address of McAfee? McAfee is a legitimate company, but this is obviously not from their email address. Most company email addresses contain all or at least part of their name, and most end with “.org” or “.com”. By clicking on the “Activate Now” button, this scammer will try to get your personal financial information. Another problem with clicking on links is that it more than likely will contain a virus that will then download onto your computer and corrupt it. NEVER click on any link that looks suspicious! Delete the email and never respond to these scammers!

“Grandma Scam”

Another popular scam against seniors is the “Grandma Scam”. You may have heard of this one already, but I actually received this phone call for the first time just recently. My own mother received the same call about a year ago, and it was almost word-for-word of mine.

I answered an unfamiliar number on my cell phone, and the caller said, “Hi Grandma, this is your grandson” (keep in mind, I have just one grandchild, a girl, who is 9 years old), but I played along for fun because I’d heard of this scam before (of course, I could have responded with, “which grandson? I have three”, but he probably would have just hung up on me). He proceeded to tell me that he’d been in an accident in a friend’s car, but was not injured ... however, his friend had lots of alcohol that was found in the car by police (this is a common story of these scams). My “grandson” had been arrested and was asking me if I could help him out with bail money. I asked how much he needed (it was \$2500), and also asked why he hadn’t called his mother first (hahahaha!). He claimed he was too embarrassed to call “Mom”. His pathetic little story went on and on, and I’ll bet he really thought he’d landed a sucker, as I kept playing along as Grandma. He then proceeded to ask if his appointed attorney could call me right back to arrange to make payment over the phone, and I responded that he was welcome to call. He ended the call after saying, “I love you, Grandma” (what a sweet touch!) I hung up with my “grandson” and the phone rang again within 20 seconds. Trying so hard to use a disguised voice, the same man called back now claiming to be my grandson’s attorney. He laid some “heart wrenching” story on me about how my grandson was terrified to be heading to court in 15 minutes, but if I paid the bail now by credit card, he could avoid facing the judge. Had I actually given him my credit card number, he could have racked up charges buying anything he wanted before maxing out my credit!

Having played along with this for several minutes as the compassionate Grandma, I then proceeded to inform the “attorney” that my grandson had always been a thorn in my side; he had manipulated me out of thousands of dollars in the past, had always been a criminal, and I suggested that he could ROT in jail for all I cared! The “attorney” (aka Scammer) was obviously dumbfounded and unprepared to receive such a response. He didn’t even know how to respond to my claims. Of course, I had used a few more “choice” words and descriptions of my “grandson” that I can’t repeat here, so he just stammered ... “Uh, I’ll let him know” and hung up on me. Hahahaha!
